You understand that the following information may be shared with other commuters for the purpose of facilitating the formation of a carpool/vanpool: Name, City, State, Email, Worksite, Work phone (if provided), Hours of Work. All other information you provide is considered private and will not be shared.
4. You understand that the information that you have provided will be shared with others in the ridematching database in order to supply you with the requested matching services. Match lists containing the information noted above will be sent to those commuters who match your commute profile.
5. In the event that you match with other commuters in the database during a match request, you will be sent an alert to let you know that your name and contact information appeared on a matchlist.
6. If at any point you wish your information to be updated, inactivated, or deleted from the commuter database, it is your responsibility to contact HART Commuter Information Services to make that request. You agree to provide HART up to five (5) business days to fulfill your request.
