----- RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT

In consideration of being permitted to participate in the Bike Rodeo program at _____,
I, for myself, my child, or my personal representatives, assigns, heirs, and next of kin:

1. Acknowledge, agree, and represent that I understand the nature of the activity and that my child and/or I am qualified and in good health and proper physical condition to participate in such activity. I further acknowledge that the activity will be conducted according to generally accepted practices by HART Commuter Information Services, and I further agree and warrant that at any time I believe conditions to be unsafe, I will immediately discontinue my, or my child's, further participation.
2. Fully understand that: (a) such activity can involve some risk and danger; (b) these risks and dangers can be caused by my child's own actions or inactions, the actions or inactions of others participating in the activity, the condition in which the activity takes place, or the negligence of the releasees named below; (c) there may be other risks and social and economic losses either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I incur as a result of my or my child's participation in the activity.
3. Hereby release, discharge, and covenant not to sue HART Commuter Information Services and their respective directors, agents, officers, members, employees, and volunteers from all liability, claims, demands, losses, or damages on my account caused or alleged to be caused in whole or part by the negligence of the releasees or otherwise, including negligent rescue operations. I further agree that, despite this release and waiver of liability, assumption of risk, and indemnity agreement, if I or anyone on my behalf makes a claim against the releasees, I will indemnify, save, and hold harmless each of the releasees from any litigation, expenses, attorney fees, loss, liability, damage, or cost that may incur as the result of such a claim.
