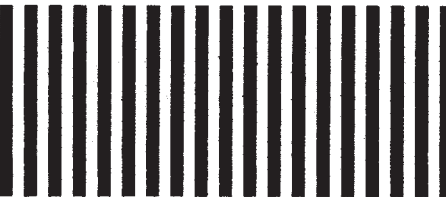

1 Save on your commute

Ridesharing is a great way to reduce commuting costs. Considering today's fuel and transportation costs, ridesharing could save you up to \$400 a month!

2 Save on taxes

The "Commuter Choice Provision" of the federal tax code lets you reduce your taxable income by up to \$105 a month through automatic payroll deductions to help pay for a vanpool.

3 Save on car insurance premiums

If you lower your car usage, your insurance company may lower your car insurance premiums.

Relax and enjoy making new friends on the way to work.

5 Emergency Ride Home

You understand that the following information requested on this form is considered as private data: (a) your residential address and residential telephone number; (b) your beginning and ending hours; (c) your current mode of commuting to and from work; and (d) the type of rideshare service information you have requested. All other information you provide is considered public data and is accessible by any person for any reason, including your name and workplace.
4. You understand that any of the information you provide, whether considered as private or public, will be provided to others in the rideshare matching database in order to supply you with the requested rideshare matching services. Match lists containing your name, town of residence, employer, telephone number(s) and email address(es) of your choice, working hours and rideshare preference may be sent.
5. If at any point, you wish your information inactivated or deleted from the commuter database, it is your responsibility to contact HART Commuter Information Services to make that request. You agree to provide HART five (5) business days from the time of your request to delete or make inactive your information.
